 **PANDEMIC NOTE: Due to changing provincial regulations, we will not deposit entry fees until just before the event, in case we need to cancel. To avoid expiring e-transfers, we can receive your payment up to March 29th at 5pm, even if your entry is submitted earlier. However, payment cannot be received after that.**

**SUMMARY OF RULES AND LEVELS – See official CKC rulebook for details.**

**DIVISIONS:** There are 3 divisions – Regular, Selected, and Veteran. A dog may enter classes in any division but, in selected, may not move back and forth between divisions during a trial. Veterans cannot move back to regular.

**Regular division** is for all dogs of any breed and any level and any jump height.

**Selected division** is for dogs that need more time or should not jump the regular jump heights. They run the same course as Regular dogs but jump one height lower and receive 10% more time than Regular division dogs. Dogs moving into the Selected or Veteran division can move laterally, and take any legs they have earned in the Regular division with them. Once a dog has moved to the Veteran division it may not move back to the Regular division. Dogs may move from the Selected division to the Regular division. However, they cannot take legs earned in the Selected division to the Regular division but must either start at the level they were already at in the Regular division or start at Novice if they had not previously run in the Regular division. The dog must be entered only in Selected division and may not move back and forth between the Selected division and the Regular division during a set of trials.

**Veteran division** is for dogs 7 years or older. Veteran dogs may jump 2 jump heights lower than regular jump height and receive 10% more time than regular division dogs. Dogs cannot revert back to Regular or Selected divisions. Veteran course times are based on dogs original jump height.

**LEVELS:** . See your rule book for definitions of requirements in each level.

There are 4 levels in Standard, JWW, and PAD. Novice, Intermediate, Excellent, and Master Excellent. No levels in Steeplechase or in Jumps and Tunnels.

**Novice:** A dog must be started at the Novice Level for each Class: Standard, Jumpers with Weaves, and PAD.

**Intermediate:** Is open to dogs that have acquired the Agility Novice title, and to those dogs which have acquired the Agility Intermediate title but have not yet acquired a qualifying score towards the Agility Excellent Title.

**Excellent:** is for dogs that have acquired the Agility Intermediate title, but have not yet earned the Agility Excellent title.

**Master Excellent:** is for dogs that have acquired the Agility Excellent title or the Agility Master Excellent title.

**Height Divisions**—owners are responsible for entering the correct height divisions. The judge may require any dog to be measured.

NOTE: As of January 2020, some breeds are allowed to jump one or two heights lower. See pages 39 & 40 of the rulebook for more information.

**Selected and Veteran course times:**

10% will be added to the standard times.

All courses have clearly designated start and finish lines with all obstacles/jumps clearly and sequentially numbered. The course layout for each class will be posted in an easily accessible area at least ½ hour before the start of the class.

**NOTE: SAME DAY MOVE UPS WILL BE ALLOWED.** e.g. Novice Standard Trial #1 to Intermediate Standard Trial #2.

**Equipment and course familiarization:**

- A warm – up area with a single practice jump will be provided for dogs entered in the trials.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. Only those entered in a class are permitted to walk the course.
- There will be no equipment familiarization period for dogs prior to the beginning of the trial.

**List of Awards and Prizes:**

- Ribbons (flats) will be provided for 1<sup>st</sup> – 4<sup>th</sup> in each class and jump height.

- Qualifying ribbons (flats) will be awarded for all dogs receiving a qualifying score in each agility trial.
- Title ribbons (rosettes) are available at the trial secretary desk.
- A Qualifying score is 85 points or more out of a possible 100 points, with no non-qualifying deductions except Master Excellent where a perfect run is required.

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing.

**Trial precincts:** The precincts of the trial are all areas reserved for the sole use of the WCOBC. The barn, parking lot, and grass areas reserved for our trial. Only Dogs entered in official classes are permitted within the precincts of the trial.

**Agility Rules and Regulations:** It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

**Withdrawal of entries:**

Anyone wishing to withdraw an entry prior to the closing date **MUST** notify the trial secretary. **After closing date only partial refunds may be provided at the direction of the trial committee. Full refunds will be provided for anyone who needs to withdraw due to illness—if you are sick, stay home!**

**Foreign Exhibitors** Entry Payment: Please note that fees are due and payable in Canadian dollars.

Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian Funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheque, “payable in Canadian Funds” or “at par”. They will not be cleared by the banks. To simplify the process, we urge that you purchase banks drafts for money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.

**General Information:**

1. All dogs are to be certified to be free of all communicable diseases.
2. Bitches in Season are not permitted to compete. Entry fees will be refunded when a bitch comes into season after their entry has been submitted to the Trial Secretary, when a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the trial.
3. Judging schedules, will be sent by email to exhibitors **on or after** March 29, 2022.
4. Before each trial the judges will provide a course design which will be posted before judging begins.

The owner of a dog entered in this event is entirely responsible for any errors in the entering of the dog, regardless of how, or by whom the entry was made. Please check your confirmations for accuracy.

**No Concession on Site**

Tim Hortons, Subway, Starbucks, McDonalds, and various other restaurants are available within 2 KM.

**Directions to Site ---- Kelowna Dog Sport Centre**

From the North: at Highway 97, immediately after the overpass, turn East (left) onto Hereron Road. Turn North (Left) almost right away onto Bulman Road. Watch for the Kelowna Dog Sport Centre sign on the right. **THIS IS A TURF FARM!** Drive down to the red barn and park on the North Side. **DO NOT ALLOW YOUR DOG TO MAKE ANY CONTACT WITH THE TURF!**

From the West/South: Travel North through Kelowna and as you are leaving the city you will see signs about Golf. Turn Right at the “go to golf” sign which is just before the overpass. (Hereron Road.) Turn North (Left) almost right away onto Bulman Road. Watch for the Kelowna Dog Sport Centre sign on the right. **THIS IS A TURF FARM! Drive down to the red barn and park on the North Side. DO NOT ALLOW YOUR DOG TO MAKE ANY CONTACT WITH THE TURF!**

**NON MEMBER PARTICIPATION FEE FORM**

## COVID-19 PROTOCOLS & SAFETY PLAN

An up-to-date COVID waiver and safety plan will be sent to registrants ahead of the event. We will be following and enforcing all public health orders and recommendations. Withdrawals with refund will be accepted for anyone due to illness or being unable to comply with our safety plan.

Expect, at minimum, the following to apply:

- You must not attend the trial if you are experiencing COVID-19 symptoms or feeling unwell. You will be asked to leave the trial site immediately if you are visibly unwell. Use this self-assessment tool before attending the trial: <https://bc.thrive.health/>
- You must not attend the trial if you have been told to isolate (e.g. due to travel or exposure to COVID).
- Always maintain a minimum 2 meters distance from other individuals.
- Be mindful: avoid touching surfaces anywhere on the trial site, including fences and gates; only course builders, ring crew, and the judge may touch agility equipment.
- Bring an adequate supply of masks and disinfectant for your personal use during the trial.
- Anticipate that many of the usual routines we have come to expect at trials are changing. Be gracious and kind in adapting to the 'new normal' of agility trialing. Without changes we will be unable to continue with any trials.
- Attendees are encouraged to sanitize their hands frequently during the trial. Handlers must sanitize their hands before and after changing jump bar heights on the practice jump.
- **MASKS ARE REQUIRED TO BE WORN EXCEPT WHEN IN OR BY YOUR VEHICLE AND 2 METERS AWAY FROM ANOTHER INDIVIDUAL OR DURING YOUR RUN. YOU MUST WEAR A MASK IMMEDIATELY BEFORE ENTERING THE RING AND AS YOU EXIT. YOU CAN KEEP YOUR MASK IN YOUR POCKET. Note: If this changes, we will let you know. Please be respectful to volunteers.**
- During the trial, the interior of the barn is off limits to everyone, except:
  - Event Superintendent
  - Trial Secretary
  - Judge
  - Volunteers
  - Handler and dog competing and the next team on the line

If needed, entries will be limited according to public health orders. Spectators are not allowed. If you **require** someone to be with you who is not involved/participating in the trial you **must** indicate this to the Trial Secretary via email when entering the trial so that the person can be registered and counted. This person must also sign a waiver and follow the safety plan.

- Parking - Parking will be as indicated by the parking attendant.
- Crating - Must be from your vehicle or limited outdoor crating area
- Course Building - Course Builders, ring crew, and the judge are the only individuals allowed to touch the agility equipment. Course builders will sanitize their hands before and after setting a course.
- Course Maps - Do not congregate at the posted maps, maintain 2 meters distance from each other.
- Judges' Briefing - Depending on the size of the event, a split judge's briefing may be implemented. Handlers must maintain 2 meters between themselves during the judge's course briefing.
- Course Walk Through - Depending on the size of the event, a split walk through or a staggered walk through may be implemented. Handlers must maintain 2 meters between themselves when walking a course. Handlers must not touch any equipment on the course, including the number cones. If there is a problem, the handler should notify the judge. Handlers must avoid congregating during the walk through and limit discussion during the walk through.

- Ring Crew - Ring crew will sanitize their hands before and after the event. Masks must be worn.
- Gate Steward & Running Order - No one is permitted into the area outlined for the Gate Steward and no one is permitted to touch the Gate Steward's equipment. Additional running orders will be posted on the outside of the barn.
- Timer & Scribe - Timer and scribe will wash their hands before and after fulfilling this activity. If the Timer/Scribe change during an event or between events, the pen/pencil and clipboard will be disinfected. Only the Timer/Scribe may touch the timing equipment and scribe sheets. The Trial Secretary will sanitize their hands and the laptop keyboard and mouse after inputting scores from each event and will wear a mask.
- Leash Running - There is no leash runner.
- Waiting at Ringside with dog - Maintain a minimum of 2 meters between teams.
- Trial Results - Trial results will be posted on the outside of the barn, not in binders.
- Ribbons & Awards - There is no self-service for ribbons. If you have earned a Q or title please notify the Trial Secretary (Sheila Brad) or Trial Superintendent (Aaryn Secker).

All trial attendees, whether competing or not, are required to provide contact information to be kept on file for 30 days in event that contact tracing is required. If an attendee becomes positive for COVID-19 within 14 days following the trial date, they must notify the host Club.

**Additional safety measures taken by the club:**

- Volunteers will encourage hand sanitizing/washing upon entry.
- Additional signage.
- Managing line-ups and potential high traffic areas to maintain distancing.
- Trial Secretary and Superintendent will field any questions or safety concerns.
- Any potential case or suspected exposure to COVID-19 will be shared with the local Public Health Unit immediately.
- Communicate safety measures in advance.
- We have assessed the main risks and high touch points associated with this event and implemented protocols to reduce the potential transmission of COVID-19.

**GENERAL (1/2)**
